Missouri State Gaming Commission

This year's ACGM Convention had the Executive Director of Missouri Gaming Commission retired Judge Peggy Richardson as a guest. The Missouri Gaming Commission has named retired Judge Peggy Richardson as its eighth Executive Director, succeeding David Grothaus. Peggy Richardson is a former judge in Moniteau County having served for over 22 years. Richardson was elected Associate Circuit Judge in Moniteau County in 1998, and she became Circuit Judge for the 26th Judicial Circuit in 2016. She received her undergraduate degree from Central Missouri State

University and her Juris Doctorate from the University of Missouri.



The Supervisor of Missouri Gaming Commission, Barbara Whittle took questions from members. Question: What are the chances of raising the payout from \$3,600 to \$5,000. The commission established

The department is currently undergoing a review of the bingo rules. They are also looking at updating the rules about attendees at the convention. Can a player reserve a seat in advance for a fee? Gerald Seelinger as Convention Chairman did the welcoming and introductions to this year's Association of Charitable Games of Missouri Convention. He welcomed first time members to the Convention. We had fifty one people attend the convention for the first time this year.





Sharing Ideas for Small & Large Bingo Halls

Lino Zamudio opened his session on Sharing Ideas. The money for incentive comes from a 50/50 raffle. Money cannot be taken from Bingo funds to pay for this. 1. Give away daubers to first time Bingo players. 2. At half time give away a gift certificate worth \$10.00, that can be used the next time they come to Bingo. This gift comes from the tally

cards. Queen of Hearts-is not part of Bingo. It is a 50/50 raffle, must be playing Bingo and must be present to win. The rules for this game is dependent upon the house rules. 3. Large Christmas Party-give away gifts collected from the community throughout the evening. 4. When donating to a charitable organization, present the check in front

of the players, so they can see where the funds are going. 5. Weekly promotion. 6. Sell event tickets during intermission. 7. When selling event tickets before the start of bingo-start with small games.

Each person who works bingo should have a business card to give to people, More fun a person has the more they spend.

Selection new Board members

You can start selling event tickets three (3) hours prior to the start of Bingo.

Gerald Seelinger conducted the election for Board members for the Association of Charitable Games of Missouri. He had a ballot with names on it and asked for nominations from the floor. Once the nominations were closed, members voted for new board members.

Illegal Gambling

Illegal gambling – The Missouri Gaming Commission has regulatory responsibility and authority over bingo licensees. We note that some organizations may feel frustration if they see other organizations who are not bingo licensees hosting Texas Hold'em tournaments, casino nights, or other types of promotions. For non-bingo licensees,

those matters are issues for local law enforcement to determine whether they want to pursue criminal charges for those activities. In addition to the potential exposure for criminal charges, if a bingo licensee hosts a Texas Hold'em game, poker game, casino night, or any other type of fundraiser, or allows any other organization to host such games

on the licensee's premises, it puts the bingo or hall licensee at risk for disciplinary actions such as suspensions, fines, or revocation of their license. Before you engage in any activity that may jeopardize your bingo license, please contact 573-526-5370 or toll free at 866-801-8643 to ensure that you are not risking your license by unknowingly engaging in illegal activity.
